Requirements for theses

Theses should be prepared in in volumes from 3 to 5 pages of text, A4 format in 1.5 intervals, 14 in Times New Roman font, 20 mm in all sides. The indent of the first line of each paragraph is 1,25.

1. Materials are typed in the following order: Name - alignment on the right-hand side; degree, position, organization, - alignment on the right-hand side; title of the report - center alignment; the text of the report

2. The name of the file must correspond to the section number and the last name of the author or the first co-author (for example: 1_Petrov.doc).

3. The report abstracts should be carefully edited. For linguistic mistakes the author is responsible.
